## Labor economics

5 ECTS
180 academic hours

The discipline starts on the 3 year of study

With this discipline, you will understand the regulations of the labor market and the principles of its functioning, get to know how to predict market tendencies

#### You will study

- principles of supply and demand in the employment market;
- —compensatory fiscal theory
- human capital: assets and perspectives
- labor mobility
- inequality in the labor market
- labor union organizations
- trends and tendencies of unemployment

- know the patterns of economics subject's behavior
- be able to apply major determinants in supply and demand in the labor market, world salary scales and key market parameters in practical cases and research
- master the fundamental methodology of the contemporary labor market research

# Contemporary international economic relations

3 ECTS
108 academic hours

The discipline starts on the 4 year of study

With this course you will get acquainted with trends of international economic relations development, the conditions of movement of factors of production, the patterns of interaction between different economic subjects of a world level

#### You will study

- the history of the development of the world's economic relations
- international economic relations as a part of international public affairs
- globalization of economics, its core, trends and future impact
- regionalization of international economic space
- development of economics

- know major trends and tendencies of world's financial and currency market and apply them for the analysis of international business
- know the theory of market pricing, as well as peculiarities of its application to pricing systems of different countries
- be able to point out and analyze the economic indexes on a country's and a world's level and use them to forecast the foreign exchange movements and the state of the currency market

## Cross-cultural management



The discipline starts on the 4 year of study

The key purpose of mastering the discipline "Cross-cultural management" is to get acquainted with different business cultures, the way the national business culture can influence the interaction on a world's level and how it affects a company's internal culture

#### You will study

- Cross-cultural management: modern tendencies and gaps. The definition of culture in terms of business
- The codependency of national and corporate culture. Western corporate cultures, corporate cultures of Asia, Africa and Middle West
- Leadership style in different cultural backgrounds

- know the major principles of cross-cultural management and define the type of a country's culture
- be able to build a country's profile in terms of its cultural background and make recommendations on approaches to corporate culture
- be able to organize efficiently the work of a group in a cross-cultural environment and apply gained skills and practices for successful resolution of conflicts

# International Economic Activity

4 ECTS
144 academic hours

The discipline starts on the 2 year of study

This discipline is designed to introduce students to the theoretical and methodological basis of shaping an international economic strategy of an enterprise and help them to develop practical skills of establishing economic relations

#### You will study

- The principles of international economic activity organization in different countries
- How to establish international economic activity within an enterprise
- How international activities in economics are regulated on a governmental level
- —The principles of customs regulation of international economic activity
- The ways of international economic activity in terms of foreign exchange control

- know the principles of assessment of an enterprise in terms of its international economic activity and be ready to apply it on a real cases
- be able to make a cost-benefit analysis and form a statistical report of an enterprise

## **Investment analysis**

The discipline starts on the 3 year of study

3 ECTS
108 academic

The "Investment analysis" course is aimed at training students to make efficient decisions in terms of investment and to help them get practical skills of investment analysis for successful business organizations activities

#### You will study

- Investment activity and its financial resources
- —The idea of an investment project, how to make it successful
- Major principles of investment analysis
- Common risks at investment analysis and how to deal with them
- IT in investment analysis

- be able to calculate the effectiveness index of an investment project in order to choose the most promising cases
